By downloading the Application from the Apple AppStore and Google Play Store, and any update thereto (as permitted by this License Agreement), You indicate that You agree to be bound by all of the terms and conditions of this License Agreement, and that You accept this License Agreement. The parties of this License Agreement acknowledge that Apple nor Google Play is not a Party to this License Agreement and is not bound by any provisions of support thereof. Spiritus Memoria d.o.o., not Apple nor Google Play, is solely responsible for the licensed Application and the content thereof. This License Agreement may not provide for usage rules for the Application that are in conflict with the latest App Store Terms of Service and Google Store Terms of Service. Spiritus Memoria d.o.o. acknowledges that it had the opportunity to review said terms and this License Agreement is not conflicted with them. All rights not expressly granted to You are reserved.

#### 1. THE APPLICATION

Spiritus (hereinafter: Application) is a piece of software created to enable users to create and store digital memorials of their friends and family in several ways; like adding photographs, video-files, audio-files and written stories - and customized for Apple and Android mobile devices. It is used to enable users to create and store the memorials, see memorials from other users and to suggest new stories to other users. The Application is not tailored to comply with industry-specific regulations (Health Portability and Accountability Act (HIPAA), Federal Information Security Management Act (FISMA), etc.), so if your interactions would be subjected to such laws, you may not use this Application. You may not use the Application in a way that would violate the Gramm-Leach-Bliley Act (GLBA).

## 2. SCOPE OF LICENSE

- 3.3 You acknowledge that is Your responsibility to confirm and determine that the app enduser device on which You intend to use the Application satisfies the technical specifications mentioned above.
- 3.4 Licensor reserves the right to modify the technical specifications as it sees appropriate at any time.
